

Privacy Policy

This Privacy Policy is intended to inform you about the types of information gathered by JC Enrichment Programs, Inc. (“we” or “us”) when you use the College Gate® & College Academy® website (the “Website”), how we use and safeguard that information, and the degree to which you may control the maintenance and sharing of your information.

We may update this Privacy Policy from time to time. You may always view the most recent Privacy Policy on the Website. Your continued use of the Website constitutes your agreement with the existing and updated policies.

Information Collection

When you access and use the Website, we will not collect any personally identifiable information about you unless you voluntarily provide such information to us by submitting a testimonial or registering a child for a program.

We may ask you to provide certain personally identifiable information such as your name, address, phone number, and e-mail address, as well as credit card or other payment information and a billing address. We use this information only as necessary to provide you with the services you have requested.

All personal financial information required to complete your purchase will be securely collected for purposes of payment processing and completing the transaction. In some cases, we may securely provide this personal financial information to a third-party vendor who handles payment processing services for the transaction.

Analytics

We may automatically and through third-party tracking services (e.g., Google Analytics) gather certain non-personally identifiable information about your use of our websites and store it in log files. This information may include internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamps, and related data. We use this information, which does not identify individual users, solely to improve the quality of our products and services. Out of respect for your privacy, we do not link this automatically collected data to personally identifiable information.

Cookies

A cookie is a small text file that is stored on a user’s computer for record-keeping purposes. We use both session ID cookies and tracking cookies. We use session cookies to make it easier for you to use the Website. A session ID cookie expires when you close your browser. We use tracking cookies to better understand how you use the Website, and to enhance your user experience. A tracking cookie remains on your hard drive for an extended period. You are free to decline cookies, but by doing so, you may not be able to take full advantage of all our offerings. We do not link the information we store in cookies to any personally identifiable information you submit while using the Website.

California Do Not Track Notice

We do not track our users over time and across third party websites, and therefore this Website does not respond to Do Not Track signals sent by your browser or mobile application. We do not authorize the collection by third parties of personally identifiable information from Website users.

Information Use and Disclosure

Notifications

If you choose to register for a program, we will send you a welcome email including information about your registration. We will also periodically send you periodic emails from us about new programs and services and upcoming events. Out of respect for your privacy, if you no longer wish to receive these notifications, you may opt-out of receiving them as instructed in each email.

Be advised, however, that you may not opt-out of receiving email notifications from us related to billing issues, or changes to our Terms of Service or Privacy Policy.

Disclosure

We understand how highly our users value the privacy and security of their personally identifiable information. JC Enrichment does not share personal information of program participants or their parents or guardians with any profit or non-profit organization, except as discussed below.

We will disclose information collected from and about you and program participants to the following entities only for the following purposes: (1) to service providers enable them to perform a business, professional or technical support function for us; (2) as necessary if we believe that there has been a violation of our Terms of Service or of our rights or the rights of any third party; and (3) to respond to judicial process and provide information to law enforcement agencies or in connection with an investigation on matters related to public safety, as permitted by law, or otherwise as required by law.

Business Transitions

In the event JC Enrichment Programs, Inc. goes through a business transition, such as a merger, acquisition by another company, or sale of all or a portion of its assets, any personally identifiable information we have on record will likely be among the assets transferred. The transferred personally identifiable information will remain subject to the provisions of this Privacy Policy or any subsequent updated versions.
